#### **CHALLENGES:**

The animal feed industry has stringent regulatory requirements. The team struggled to track and monitor staff training, performance, and compliance. A lack of standardisation made it difficult to consistently adhere to regulations and maintain quality standards across all operations.

Disjointed and manual processes made staff training and HR processes, like employee performance management, more difficult, resulting in inconsistent employee training records that were unfit for purpose.

The Ambar team explored other Learning Experience Platform (LXP) providers, which required additional charges for essential features. However, Blossom offered these features as part of the package, along with the flexibility to customise according to their specific needs.

#### **PROBLEMS SOLVED:**

- Ambar now has an efficient and unformed way of tracking and monitoring all employee education and training
- Communication between managers and employees has improved. With easy-touse portals, all users can find information at their fingertips without having to search through pages of content
